



February 24th, 2025 Meeting Minutes

\$35.05 donations collected

- A NeatStreets cleanup event for picking up trash along the streets of Sevenhills is set up by the township for Saturday April 26th, 9AM to 12 PM. Will have additional dumpsters for a dump your junk event. It was stressed we need volunteer support from the neighborhood to qualify for future dump your junk events. [Event details from township are HERE](#).
- Brought a few copies of the zoning code for food trucks, and discussed how to interpret permits and time at location rule. 1 permit allows 12 times per year at that location to purchase additional permits for other locations in that year. Cost, \$50 per permit.
- Discussed a recent issue on Bluehill where an arrest was made and someone was taken by ambulance.
- Discussed neglected condition of a section between sidewalk and street by the House Joint on Roosevelt and who is responsible for maintenance. Will ask Public Works.
- Discussed possible fence zoning violation on the empty parking lot adjacent to Sevenhills Dr. located in Forest Park, used for storage of construction equipment (see picture next page). Will contact Forest Park zone enforcement.
- Discussed possible zoning violation for garbage cans that are permanently left out by street.
- Talked about excessive dust in the neighborhood from concrete recycle facility and if something can be done about it.
- Talked about an issue with watershed on Aspenhill that attracts mosquitos due to standing water.
- The last township newsletters sent out Dec 2023 was not received by all residents. Was informed newsletter are now sent by email only to save cost. [You can sign up for newsletter HERE](#).
- Talked about ways to make Sevenhills park (former Frost Park) usable for soccer. As is, it's too rutted and uneven to run on without risk of ankle injury. Will bring attention to public works. Discussed setting up Saturday soccer to use the park. Shottelkotte Park can be used now, but In August 2018 the township entered into a lease agreement for exclusive use and maintenance with the [STAR Soccer Club](#), so other groups or individuals may have limited or no access to those facilities during the times allocated to the club. Gates are closed, open to foot traffic only when not in use by Star Soccer (see picture next page).
- Talked about MTIF (Metro Transportation Infrastructure Fund) to subsidize repaving of Sprucehill and other nearby roads. Too many other projects already approved for this year. A 10 year property tax assessment will also need approval by nearby owners for any repave projects.
- A request has been put in for a bus shelter with pull off slab on Roosevelt for route 7 end of line. Still waiting for information.
- Brought attention to some of the Township Services already offered (Drone lessons used as example) and to check out website for details.
